1. Description:

The Written Procedure in accordance with article 7 of the Rules of Procedure of the Monitoring Committee (MC) of the (INTERREG VI-A) IPA Bulgaria - Türkiye Programme 2021-2027, for consideration and approval Annual Implementation Report for 2022 of INTERREG-IPA CBC Bulgaria - Türkiye Programme 2014 - 2020, for amendment of Indicative Technical Assistance Budget for 2023 of the National Authority and for amendment of the Eligibility of Technical Assistance Expenditures under Interreg - IPA CBC Bulgaria - Türkiye Programme 2014 - 2020 was initiated by the Deputy Minister of Regional Development and Public Works, Bulgaria and Co-Chairperson of MC on 10.05.2023.

The official letter No. 99-00-2-111/10.05.2023 was sent to the MC members via e-mail.

The Annual Implementation Report for 2022 has been prepared by the Managing Authority and the Joint Secretariat in cooperation with the National Authority, containing summarized data on the progress made and the results achieved in 2022.

The NA submit request for amendment of the Indicative Technical Assistance Budget for 2023 by increasing it with saving from Technical Assistance Budget for 2022 of the NA, thus increasing it to 273 711,68 EUR.

The amendment of the Eligibility of Technical Assistance (TA) expenditures are related to the approved amendment of the Bulgarian Decree for Mission in the Country.

The MC members were given **5 (five)** working days to send their approval or comments on the aforementioned documents.

No comments were received from the MC members within the set deadline and therefore according to the Rules of Procedure of the MC the proposed documents are deemed approved.
