## 1. Description:

The Written Procedure in accordance with article 7 of the Rules of Procedure of the Monitoring Committee (MC) of the (INTERREG VI-A) IPA Bulgaria - Türkiye Programme 2021-2027, for consideration and approval of Evaluation report for performed assessment procedure of one project proposal selected for financing under Restricted Call for Strategic Project Proposals ref. No 2021TC16IPCB005 – 2022 – 1 under (INTERREG VI-A) Bulgaria - Türkiye Programme 2021 – 2027, was initiated by the Co-Chairperson of MC on 06.06.2023.

The official letter from 06.06.2023 was sent to the MC members via e-mail.

The Assessment Working Group (AWG), comprising of members of the Managing Authority, National Authority and the Joint Secretariat, performed their duties in full accordance with the Assessment Rules for the Restricted Call for Strategic project proposal, which was subject to approval by the Monitoring Committee prior to the start of the assessment process.

After detailed review of the provided additional documentation, the assessors reported that the Strategic project proposal complies with most of the assessment criteria set in the Guidelines for Pre-Defined Applicant. However, few documents shall be requested during the contracting procedure. Consequently, the application with ref. No





BGTR0100002 is proposed for approval by decision of Monitoring Committee under the following conditions:

- 1. During the contracting procedure the Project Partner 4 Edirne Governorship shall present supporting documents in accordance with the requirements in point 3.2 Supporting Documents section B5 from GfA, concerning the investment component (ownership act, consent of the owner, permits, approvals and other documents related to the investment activities) or legal statement from relevant authority that the Activities are not subject to permitting.
- 2. Project Partner 4 Edirne Governorship and Project Partner 5 Kirklareli Governorship shall provide revised Decision of the Local Council/Board of Directors/ any similar body or managing person regarding the project development, implementation and ensuring the sustainability of the project results for five years after completion of the implementation period (3.2 Supporting documents, Part B2 of the GfA).
- 3. Project Partner 4 and Project Partner 5 shall provide Justifications under Budget category 5 "Equipment" for all unit types "per contract" which shall include information for the number of the items that are part of the unit listed in the "Technical Specification for supplies".

The MC members were given **5** (five) working days to send their approval or comments on the aforementioned documents.

No comments were received from the MC members within the set deadline and therefore according to the Rules of Procedure of the Monitoring Committee the proposed documents are deemed approved.

## 2. Decision:

1. The Monitoring Committee approves the Evaluation report for performed assessment procedure of one project proposal selected for financing under the Restricted Call for Strategic
