**1. Description:** The Written Procedure in accordance with article 7 of the Rules of Procedure of the Monitoring Committee (MC) of the (INTERREG VI-A) IPA Bulgaria - Türkiye Programme 2021-2027, for consideration and approval of the amendment of the Eligibility of Technical Assistance Expenditures under Interreg – IPA CBC Bulgaria – Türkiye Programme 2014 – 2020, approval of the job description of Project Manager, Monitoring Expert and Monitoring Expert profile „Monitoring of Investment Projects” within the Joint Secretariat Edirne Branch Office and approval of the Evaluation plan for (INTERREG VI-A) IPA Bulgaria - Türkiye Programme 2021-2027.
