Written Procedure No. 14, initiated on 12th of June, 2024

1. Description: The Written Procedure in accordance with article 7 of the Rules of Procedure of the Monitoring Committee (MC) of the (INTERREG VI-A) IPA Bulgaria - Türkiye Programme 2021-2027, for consideration and approval of:

1. Rules for Screening Process under guide for identified applicants to develop and submit full project proposals under Priority 2 “Integrated Development of the Cross-Border Region”, and
2. Corrigendum of the Application package for pre-defined applicant under restricted Call for Governance Project Proposal under Priority 2 “Integrated development of the cross-border region” (Guidelines and Annex 1).

The MC members were given 10 (ten) working days to send their approval or comments on the documents.
