1. Description: Pursuant to article 7 of the Rules of Procedure of the Monitoring Committee (MC) of the (INTERREG VI-A) IPA Bulgaria - Türkiye Programme 2021-2027 Written Procedure No. 20 was initiated for the consideration and approval of the following:

1. Report on the screening process of the Full Project Proposals (FPP) received under the Targeted Call for development and submission of FPP under Priority 2 "Integrated development of the cross-border region" of (INTERREG VI-A) IPA Bulgaria Türkiye Programme.

2. Proposal 2 211 765 EUR of the envisaged amount for Specific objective 2 "Development of better access to services of general interest (SGI)" of the Territorial Strategy under (INTERREG VI-A) IPA Bulgaria Türkiye Programme to be allocated for financing the project proposals, included in the reserve list of the Targeted Call for Full Project Proposals under Priority 2 "Integrated development of the cross-border region" (SO1 of Territorial Strategy).

3. Introduction of provisions related with the competency of Turkish legal authorities about the debts of Turkish lead partners or project partners to the National Authority.

The NAMRB, Republic of Bulgaria and Edirne Municipality, Republic of Türkiye have expressed approvals, outlined in Attachment 1 – Table of comments.

No objections or additional comments were submitted by the MC members within the stipulated timeframe.
